# 1. Review of Draft Zoning Ordinance

Commissioners reviewed Articles 1-5 and asked for clarification and explanation on many items including; figures and tables throughout the draft, minimum residential home size requirement, how garages face and their setbacks, home occupation, accessory dwelling units, and live/work units.

The Commissioners all agreed that they want more time with the Draft and asked that the Public Hearing be pushed back again. They also agreed on adding another meeting for them to review the Draft. The Commission requested staff to secure a location and time for an additional meeting in August.
