

Saugatuck Township Regular Meeting Minutes Wednesday, November 8, 2023, at 6:00 p.m. Saugatuck Township Hall Meeting held in person & via Zoom

Call to Order: Clerk Israels called the meeting to order at 6:00 PM

New Business:

1. Moratorium Extension Resolution 2023-17

In May 2023, the Township Board enacted a six-month moratorium on commercial and industrial development to allow for a comprehensive update to the Zoning Ordinance. The Planning Commission is diligently reviewing the update, with the first public hearing anticipated in December. To accommodate the extended review, Staff recommends extending the moratorium for an additional six months. During the moratorium, the Township won't accept applications for commercial or industrial developments, excluding certain project types. The moratorium will last for six months or until repealed by the Township Board, excluding projects currently under consideration by the Planning Commission, of which there are none presently.

Helmrich emphasized that the moratorium could be lifted ahead of schedule if necessary, underscoring that its purpose is to guarantee the thorough completion of the Planning Commission's work on the draft Zoning Ordinance.

2. 123.Net METRO Act Permit Application

123.Net, Inc. has submitted a METRO Act Permit Application for installing fiber optic cable in Saugatuck Township's public Right of Way. The METRO Act, established in 2002, streamlines the permitting process for telecommunication providers, ensuring timely approval or denial within 45 days. Compensation to municipalities is provided annually by the METRO Authority. The Township Attorney has confirmed the application's completeness and compliance with the standard form developed by the Michigan Public Service Commission.

Helmrich updated the Board on the Allegan County Broadband Internet Access Project, noting the distribution of project-related postcards with instructions for the public. In response to Israels' query about the number of Township residents lacking broadband access, DeFranco explained that the majority face various obstacles, emphasizing the project's significance as one of the Board's priorities for the year.

3. Wiley Rd SAD Increased Assessment Resolution 2023-18

In February 2023, the Board approved Resolution 2023-02, setting the initial cost estimate for the Wiley Rd water main extension at \$150,809.00. After receiving three bids on October 26, 2023, the lowest bid amounted to \$158,900.00, resulting in a 31.46% increase, bringing the new estimated cost to \$198,250.50. Participants in the Wiley Rd SAD have been informed and expressed support for moving forward.

Act 188 of 1954, MCL 41.732, stipulates that, in case of a special assessment roll insufficiency, the township board should make additional pro rata assessments without exceeding the value of benefits received from the improvement.

Helmrich inquired about the cost discrepancies, and DeFranco clarified that they arise from various fees necessary for the project. Israels sought clarification on whether this constituted an amendment to the previous resolution or an entirely new resolution. DeFranco explained that it is a new resolution specifically intended to amend the previous one.

The Township Engineer has reviewed all bids and recommends awarding the project to Georgetown Construction. The anticipated completion date for the project is June 14th, 2023.
