To be considered complete, the application must include answers to all questions and all required attachments.

Land division approval is required before:

- Selling the property
- Leasing the property for more than one year
- Creating a new parcel smaller than 40 acres (excluding property line adjustments)

Your application status will be marked "pending" during the preliminary review stage and will become "active" once it enters the Official Review Process.

For reference, see the Land Division Ordinance and the Michigan Land Division Act (formerly the Subdivision Control Act, P.A. 288 of 1967, as amended by P.A. 591 of 1996, MCL 560.101 et seq).

I acknowledge that if local ordinances or state laws change, any approved divisions must comply with the new requirements unless deeds, land contracts, leases, or surveys reflecting the approved divisions are recorded with the Register of Deeds, or if development begins before such changes take effect. I understand that approval of this division does not quarantee future building permit approval. If this division is approved, I agree to record the necessary document(s) with the County Register of Deeds and file them with the Township within 90 days of approval.
