Board members discussed the diverse interests of community members, challenges in enforcing a no wake zone, and whether a no wake zone would be supported by the Municipalities. Cummins noted Saugatuck City's work on researching the process of establishing a no-wake Waskin requested that the Municipalities publish a survey to gauge public support for a no-wake zone on Lake Kalamazoo.





Q3 If yes, what type of boat do you own? (Check all that apply)



Q4 Do you rent or own a slip, on Kalamazoo Lake?





Q5 What activities do you primarily engage in on Kalamazoo Lake? (Check all that apply)





Q6 Have you observed or experienced situations on Kalamazoo Lake where wakes contributed to safety risks (for example, near-misses or accidents)?







Q8 Do you support expanding the no-wake zone around marina areas?





Q9 Do you support making Kalamazoo Lake no-wake for vessels over 26 feet?






